

**OXFORDSHIRE COUNTY COUNCIL  
(WARDINGTON PARISH) (SPEED LIMITS) ORDER 202\***

The Oxfordshire County Council, in exercise of its powers under Sections 82, 83 & 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to that Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Wardington Parish) (Speed Limit) Order 202\* and shall come into force on the . day of 202\*.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour in the lengths of road specified in Schedule 1 to this Order.
3. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour in the lengths of road specified in Schedule 2 to this Order.
4. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3(5) of those regulations.
5. The Oxfordshire County Council (Wardington Parish) (Speed Limits) Order 2020 is hereby revoked.

**SCHEDULE 1**

**20mph speed limit:**

**Wardington and Upper Wardington**

The whole length of every road excluding those roads or lengths of road listed in Schedules 2 or 3), in the villages of Wardington and Upper Wardington extending (in the case of the respective roads leading out of the villages) to the following points:

a)	A361 Banbury-Daventry road (northern end)	a point 140 metres northwest of its junction with the northern junction of the unnamed road running north-eastwards to Edgcote.
b)	A361 Banbury-Daventry road (southern end)	a point 175 metres southwest of its junction with the unnamed road running southeast through the village towards Upper Wardington.
c)	Edgcote Lane	a point 114 metres northeast of its junction with the A361 Banbury to Daventry Road.

d)	Thorpe Road (south-eastern end)	a point 228 metres southeast of its junction with Chelmscot Row.
e)	Thorpe Road (south-western end) running southwest from Upper Wardington to the A361	a point 135 metres southwest of its junction with Mount Pleasant.

### Williamscot

f)	Cropredy Lane	from a point 31 metres southeast of its junction with the unnamed road g) below, north-westwards	for a distance of 333 metres.
g)	The unnamed road linking Cropredy Lane to the southerly junction of the A361	from its junction with Cropredy Lane, southwards	to a point 15 metres northwest of the A361.

### SCHEDULE 1

30mph speed limit:

### Wardington and Upper Wardington

The whole length of every road in the villages of Wardington and Upper Wardington extending (in the case of the respective roads leading out of the villages) to the following points :-

a)	A361 Banbury-Daventry road (northern end)	a point 140 metres northwest of its junction with the northern junction of the unnamed road running north-eastwards to Edgcote.
b)	A361 Banbury-Daventry road (southern end)	a point 175 metres southwest of its junction with the unnamed road running southeast through the village towards Upper Wardington.
c)	Edgcote Lane	a point 114 metres northeast of its junction with the A361 Banbury to Daventry Road.
d)	Thorpe Road (south-eastern end)	a point 228 metres southeast of its junction with Chelmscot Row.
e)	Thorpe Road (south-western end) running southwest from Upper Wardington to the A361	a point 135 metres southwest of its junction with the unnamed road running north west through the village to the A361.

## Williamscot

f)	The unnamed road running in a general southeast-north-westerly direction from the northerly junction of the A361	from a point 31 metres southeast of its junction with the unnamed road g) below, north-westwards for a distance of 333 metres.
g)	The unnamed road linking f) above to the southerly junction of the A361	from its junction with the unnamed road f) above to a point 15 metres northwest of the A361.

## SCHEDULE 2

### 50mph speed limit:

a)	A361 Williamscot Hill to Wardington	from the county boundary at a point 1784 metres south-west of its junction with the road linking Wardington Road north of Chacombe to the A361 south of Williamscot, north-eastwards	to a point 175 metres southwest of its junction with the unnamed road running southeast through Wardington towards Upper Wardington.
b)	A361 Wardington to County Boundary	from a point in Wardington 140 metres northwest of its junction with the northern junction of the unnamed road running north-eastwards to Edgcote, in a general northerly direction	for a distance of 944 metres to the county boundary.
