What are we doing?

Construction of the new section of the A361 near Chipping Warden continues this summer. As we prepare to connect the new section of road to the current highway, we will be excavating a section of the road and installing safety barriers. Once in place, we can work safely behind the barrier as we continue to build the new road.

To excavate the roadside area and install the concrete safety barriers, we require a weekend road closure near the entrance to our compound.

Work on the A361 realignment will continue throughout 2025 and some additional traffic management will be required later this year.

When will these works take place?

8pm Friday 25 July until 8pm Sunday 27 July 2025.
