What are we doing?

In preparation for the realignment of the new section of the A361 near Chipping Warden, over the green tunnel, we will install new road signage in the area.

A daytime closure is required to replace the signs on the Byfield Road in Chipping Warden. The new sign will accurately depict the new road layout, and directions from the roundabout on the A361.

A signed diversion for the road closure will direct traffic via the A361 bypass and is shown on the map on the following page.

Work on the A361 realignment will continue throughout 2025 and some further traffic management will be required later this year.

When will these works take place?

During the week of Monday 15 September to Friday 19 September 2025. If existing street furniture (posts) can be reused, the closure may only take one or two days. A closure will be required from 8.30am to 5.30pm.
